- ✓ Adjusted medians are based on regression analyses of ratings over the previous two academic years in all classes at the respective institution and correct for factors such as class size, expected grade, and reason for enrollment.
- ✓ Challenge and Engagement Index highest scores is 7 and asks students how academically challenging they found the course to be.
- ✓ For sections with * unadjusted median is reported.
- ✓ FYO sections are special seminar sections for underprepared, first-year students only.
